## **Prerequisites and Conditions of Connection**

- Other than the lot to be serviced, if another property is affected by excavation works, permission must be obtained from relevant owner(s) prior to application.
- The applicant is responsible for engaging a suitably qualified and licensed Plumber to undertake all plumbing works associated with the installation of the sewer junction.
- Under Section 90 of the Water Service Act: A person must not drill, bore, excavate or use impact
  equipment within the prescribed proximity to water service works, of a prescribed kind, of a licensee,
  or engage in any other activity within the prescribed proximity that may damage those works, except
  in accordance with the approval of the licensee. The applicant must have received prior approval
  from Water Corporation to work near our assets by applying for an Asset Protection Risk Assessment
  (APRA). Approval can by obtained by submitting an application to work near our assets via

- The applicant is responsible for all excavations to allow Water Corporation personnel access for the installation of the additional sewer junction. Any excavation work shall be made safe for entry by Water Corporation personnel to Worksafe Western Australia's requirements.
- All plumbing works are to provide a satisfactory gravity connection, in accordance with the Water Services Licensing (Plumbers Licensing and Plumbing Standards Regulations 2000).
- The applicant is responsible to ensure the excavation is backfilled and compacted to the required Australian Standard and that the area is restored to its previous condition so far as is reasonably possible.
- Prior to connecting the property, or any building, to the sewer main, it is a legal requirement that the
  plumber makes application to the Plumbers Licensing Board and Water Corporation as well as pays
  the connection charges.
- On completion of the work the plumber is required to prepare an as constructed drawing of the
  connection details and submit the drawing to Water Corporation at PO Box 100 Leederville WA 6902
  or by email to <a href="mailto:building.services@watercorporation.com.au">building.services@watercorporation.com.au</a> OR if for a <a href="mailto:subdivision">subdivision</a> to

  for example blockages of the plumbing).
- In the event that the site is unsafe OR the necessary clearances are not available OR the plumber is not in attendance at the agreed time Water Corporation reserves the right to recover the cost of any lost time from the applicant.
